DECRETA

Art. 1

1. The final deadline for the submission of applications for admission to the AFAM Research Doctorate Course in "PEDAGOGICAL THEORIES AND EDUCATIONAL RESEARCH FOR THE STUDY OF PERFORMANCE AND CREATIVE PROCESSES IN THE MUSICAL FIELD" (DOT243RAB3) - XLI Cycle A.Y. 2025/2026, previously set for December 15, 2025, 12:00 PM (CEST), is **extended to December 30, 2025, 12:00 PM (CEST)**.

2. All other provisions and conditions established in the Competition Announcement, Prot. n. 3977 of 01/12/2025, including the application submission procedures and admission requirements, remain firm and unchanged.
